Join the IGC:

The Interactive Gaming Council welcomes your membership. To apply, an applicant must meet the qualifications for a (1) Full, (2) Associate or (3) Affiliate member and must submit a completed application form with supporting documentation. Full and Associate applicants must also remit a non-refundable one-time application fee of US\$500.00 (plus GST for Canadian Applicants). Each application will be assessed on a case-by-case basis and may depend upon the results of background checks. Further information on the categories of membership can be found in the IGC Bylaws on the web site (www.igcouncil.org and "Members Forum" link).

Before completing the application form, **please read the instructions and qualifications below carefully.**

Failure either to fully disclose all known information, or to provide complete records as required, may be sufficient reason for the application for IGC Membership to be refused.

Note that all fees are payable in US Dollars. You will be notified of your acceptance to membership and invoiced for your membership dues.

The Application Fee is to be paid by check or bank wire if preferred (banking coordinates will be issued once application form is received) to the address above. Processing will NOT commence until the receipt of both a completed Application Form and the Application Fee.

QUALIFICATIONS (Cross out whichever is not applicable):

(1) A **Full** Member may be: (effective 1 January 2002, **Annual** dues - **US\$10,000** plus GST for Canadian Members / Applicants)

- A. An entity or its duly authorized representative or assignee, who shall be duly licensed or otherwise sanctioned, nationally or internationally, by a recognized governmental body, hereinafter referred to as possessing a "Gaming License", to own, operate and/or maintain an interactive gaming operation, including but not limited to a casino, sports book, lottery or bingo establishment, accessible through either public or private telephonic and/or electronic networks (internet, intranet or other electronic communications); and
- B. An entity that provides products and/or services integral to interactive gaming operations, including but not limited to gaming software designers and vendors.

(2) An **Associate** Member may be (effective 1 January 2002, **Annual** dues - **US\$3,000** plus GST for Canadian Members / Applicants):

- A. An entity who, while not directly engaged in the ownership and/or maintenance of a gaming operation, or the designing and development of gaming software and operations, is nevertheless a provider of services to either the gaming operator and/or software developer or the general public regarding the interactive gaming business; and

- B. An entity that, while not currently qualifying as a Full Member as defined above, contemplates owning and/or operating a gaming enterprise. The entity qualifying as an Associate Member under this provision may participate as an Associate Member until such time as the Associate Member shall be admitted as a Full Member after review and approval of the Board of Directors. Associate Members shall include prospective owner/operators who have not commenced operations or who may have temporarily suspended operations. Upon commencement or recommencement of operations, such Associate Member shall become a Full Member, subject to the Board of Directors approval, or shall be reinstated to a Full Member as appropriate,

with all rights and obligations entitled to a Full Member, including, but not limited to, increased Association dues and fees, if any.

(3) An **Affiliate** Member may be (**Annual** dues are **US\$500** - plus GST for Canadian Members / Applicants):

A. An individual or organization who shall be a member of any recognized governmental agency or authority; or

B. A not-for-profit organization providing services to the online gaming industry.

INSTRUCTIONS:

1. Note that failure either to fully disclose all known information, or to provide complete records as required, may be sufficient reason for the application for IGC Membership to be refused.
2. Each applicant must be listed by its proper, legal name (if an entity such as a corporation or partnership) or full legal name if an individual and its address of legal residency (the location where the executive offices are situated).
3. Each applicant must designate **ONLY ONE** primary contact.
4. Each applicant must list the proper URL for the member's corporate or main web site. You should also enter the web site name and address for each other site solely owned by you and on which you wish to be allowed to display the IGC logo. For Owner/Operator applicants these sites may be all casinos and/or sports books owned entirely by the applicant only. If the applicant is a partner with another individual or entity, or if the casino/sports book is owned by a subsidiary of the applicant, that partnership or subsidiary must also be a member before it may display the membership logo unless the applicant has agreed in writing to be responsible for the obligations of the subsidiary/partnership and such agreement has been filed with the IGC.
5. To assist the IGC in referring other members and non-members to the services provided by Members, an Applicant is requested to provide the 3 primary services that the Applicant offers (e.g. type of gaming operation, software supplier, hardware supplier, legal counsel, equipment testing/evaluation, lobbying, research, gaming consultant, financial services, advertising and marketing, etc).
6. The Applicant, by submitting the Application Form, agrees to permit the IGC or its agent to use the above information to perform whatever checks the IGC deems appropriate, including contacting third parties, to process the application. A successful Applicant must agree to comply with the IGC Bylaws, any Membership Rules and Regulations, and the IGC's Code of Conduct.
7. Failure to give true and correct answers to any questions in this form may constitute grounds for the Interactive Gaming Council to refuse an application or to revoke membership that has been granted on the basis of untrue or incorrect, including incomplete, information.
